Teens Leading the Next Generation of Artists and Audiences

Application Requirements:

- Must be in high school (grades 9-12) at the starts of the 2018/2019 school year
- Must make a nine-month commitment (September-May), with mandatory meetings twice a month on Mondays from 4:30pm to 6:00pm at CSC; additional time commitments will depend on the interests of the individual student and the events planned by NextGen members throughout the course of the year
- Must be responsible for transportation to and from CSC (136 East 13th Street)
- Must demonstrate considerable leadership skills and a desire to learn about all aspects of professional theater

Application Components:

- **Contact Information** (student, parent/guardian, emergency) – COMPLETE ONLINE
- **Short answer essay questions** – COMPLETE ONLINE
- **Letter of recommendation** – Ask a professional who knows you well (teacher, program coordinator, religious leader, mentor, etc.) to write you a short letter of recommendation.
